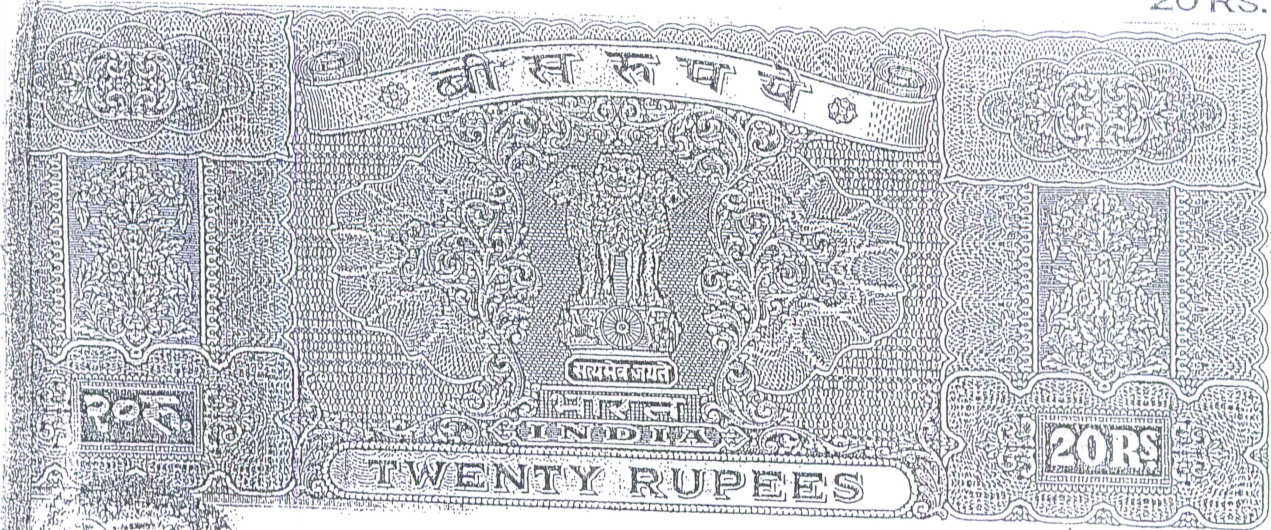

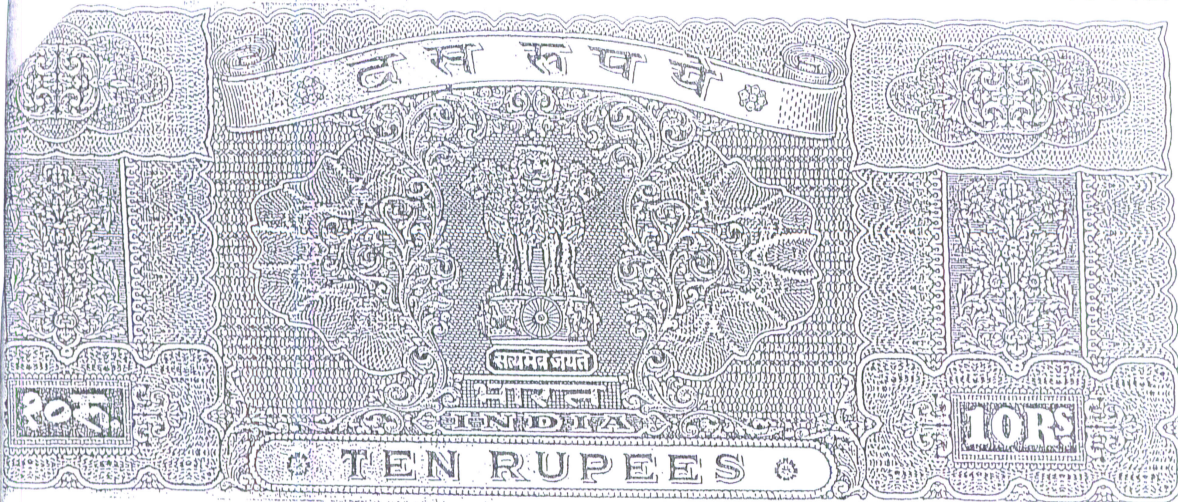

- (t) To provide medical facilities and orphanages to the poor and also provide necessary aid and help to the aged and disabled.
- (u) To promote women welfare.
- (v) To promote legal knowledge, legal aid.
- (w) To promote alternate energy.

BOARD AND ADMINISTRATION:

- 1) Fr. B. Russel Raj, the Founder shall be the Managing Trustee of the Trust Board till his life time and he shall have powers to nominate other office bearers such as Treasurer, Secretary etc., during his life time and thereafter such

- office bearers including the Managing Trustee, Secretary, Treasurer and other members shall be elected by the Board of Trustees from among themselves, giving due consideration to the intention the founder Trustee in this regard.
- (2) The first Board of Trustee shall consist of the Founder of the Trust and six others nominated by the Founder Trustee, in other words the President vide Annexure I of the Schedule.
- (3) The president of the Trust Board shall have all powers of management of the Trust and its properties in consultation with other members of the Board of Trustees and shall have powers to delegate any of his powers to any of the Trustee or Trustees as he may deem fit.
- (4) The Managing Trustee shall be in sole charge of the entire functions of the Board of Trustee and shall be entitled to act, for, and on behalf of, in the name of the Board of Trustees. Without prejudice to the foregoing General Authority granted to the Managing Trustee, all accounts of income from the trust properties, operate bank accounts in the name of the Trust properties, incur expenditure for the administration of the Trust, collect funds and take all action and legal or other proceedings, before any Court or Authority whatsoever in the name of the Trust.
- (5) The Trustees other than the founder and Managing Trustees of the Trust shall hold power-office for a period of three years from the date of nomination.

- 6) Any vacancy in the Board of Trustees occurring under clause 10 or otherwise shall be filled in by the founder till his life time and thereafter the same shall be by co-option by other members of the Board, after the demise of the founder.
- (7) Once in every three years, three members of the Board of Trust other than the Founder & Managing Trustee shall retire by Rotation. The name of the trustees who shall so retire by rotation shall be determined by lot at a meeting of the Trustees.
- (8) Notwithstanding anything contained in clause 12th first of the retirement of three Trustees and the remaining Trustees shall retire at the expiry of their moral term or at the expiry of three years after the demise of the Founder Trustee whichever is earlier. The name of the Trustee who shall retire shall be decided as provided for in clause 12 above.
- 9) The Board of Trustees shall have full power to make rules and regulations for:-
  - (i) Summoning of meeting of the Board of Trustees including its quorum preparation, Agenda for meetings, voting and recording of minutes of such meetings.
  - (ii) Constitution of separate committees for the different activities of the Trust.
  - (iii) Acquisition, sale, management and administration of Trust properties.
  - (iv) Investment and application of Trust funds for purpose approved by the income Tax Department/Act.

- (v) Employment of Staff members for the efficient economical management of Trust from time to time and their conditions of service including recruitment and imposition of punishment such as fine, suspension, removal and dismissal.
- (vi) Setting apart such percentage of receipts every year as may be decided by the Board of Trustees for the proper upkeep and maintenance of the Trust properties both movable and immovable.
- (vii) Carrying out the objects and intentions of the founder of this Trust.
- (viii) Operation of Bank account.
10. The Board of Trustees shall have powers to borrow money from any Bank of Banks or any Financial institutions, individual, Government and Quasi Government, Enterprises, Corporations for the purpose of the Trust.
11. The Board of Trustees shall have power to add or to amend any of the items of charities, herein before provided or herein after undertaken.
12. The Trust hereby created in is irrevocable.

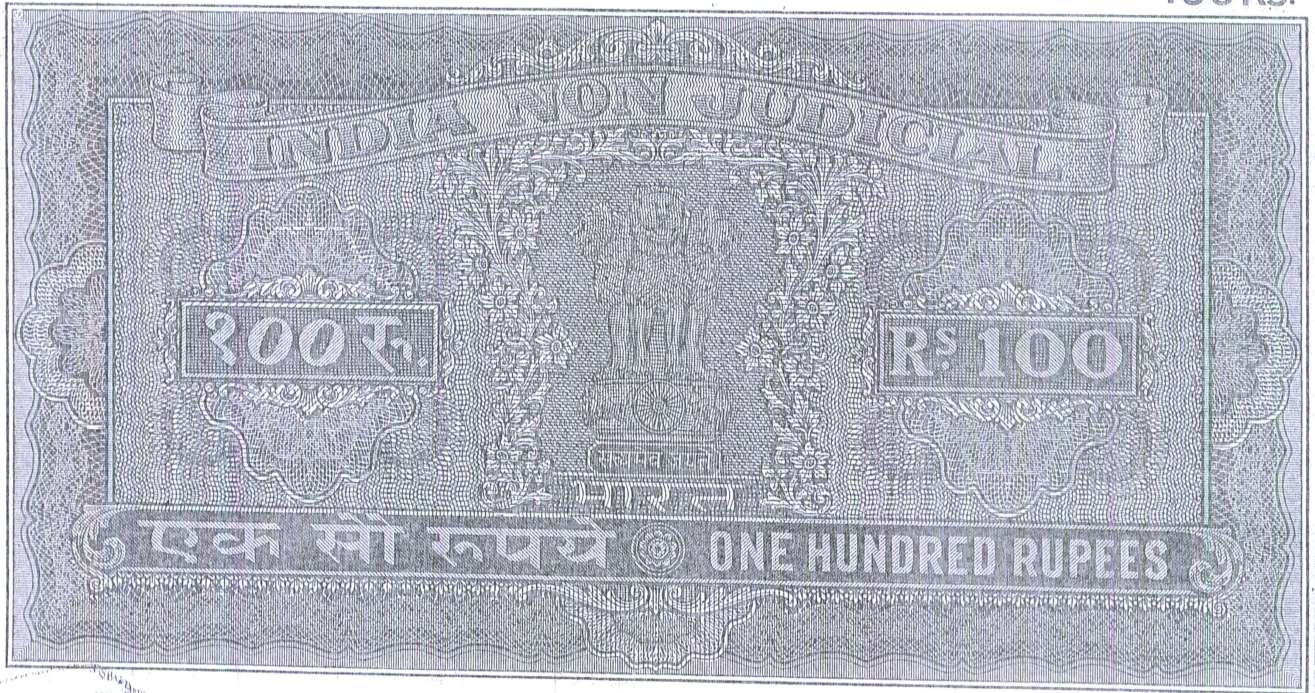

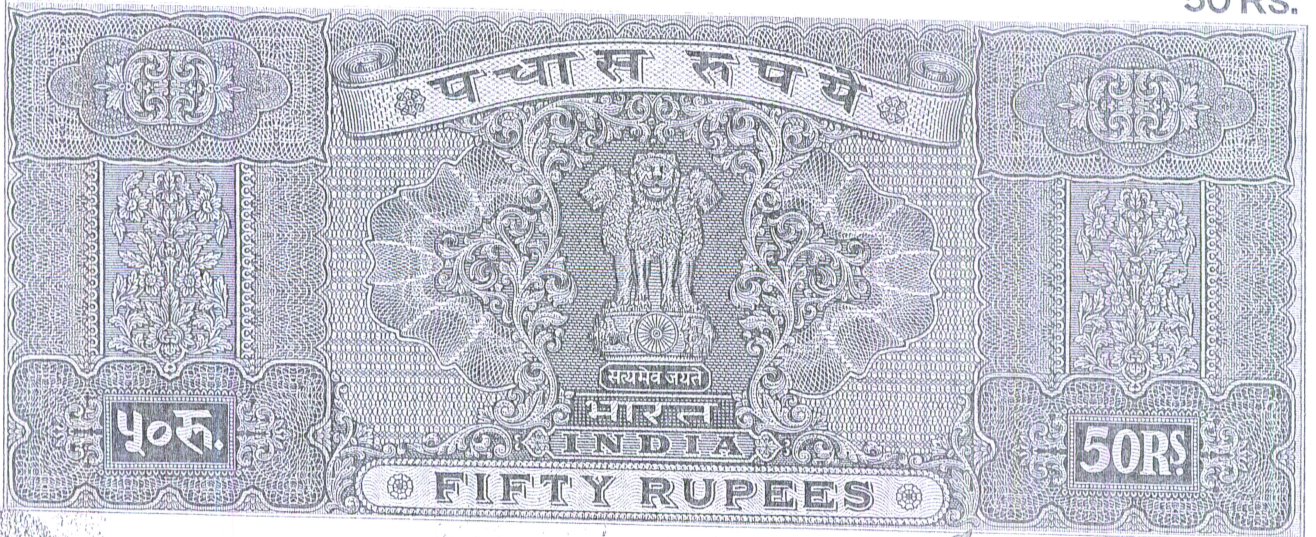

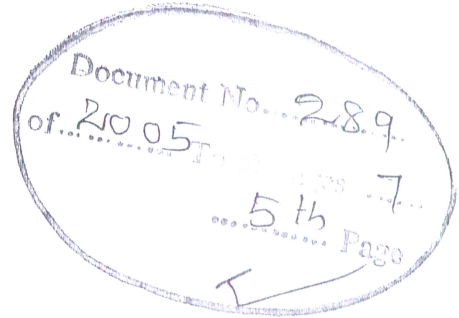

6. That the school will not open classes under CBSE pattern particularly class IX / X / XI / XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent / Manager of the school have individually gone through the provisions contained in the affiliation & examination bye-laws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination bye-laws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
10. That the school will ensure that all required infrastructure is available with the school before starting classes.
11. That the school will ensure that sufficient number of qualified teaches as per the provisions contained in affiliation bye-laws are available with the school before starting classes.

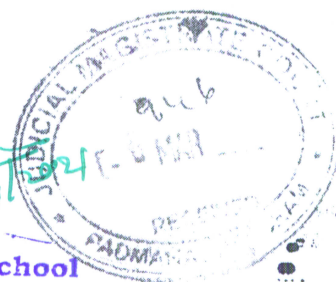
